

# PROCLAMATION

## OFFICE OF THE MAYOR OF THE CITY OF FORT SMITH, ARKANSAS TO THE PEOPLE OF THE CITY OF FORT SMITH

**WHEREAS**, a 15-day filing period was held May 11, 2016 thru noon on May 26, 2016, for the positions of City Director Wards 1, 2, 3 and 4; and,

**WHEREAS**, four (4) individuals filed and have been certified as candidates for the position of City Director Ward 4 thus necessitating a municipal primary election in accordance with Arkansas State Code § 14-48-109(a)(7); and,

**WHEREAS**, the municipal primary election shall be held on the second Tuesday of August preceding the municipal general election in accordance with Arkansas State Code § 14-48-109(a)(2)(B)(i);

**NOW, THEREFORE, I, SANDY SANDERS**, Mayor of the City of Fort Smith, Arkansas, by virtue of the authority vested in me by law, do hereby proclaim that a **municipal primary election** will be held for registered voters of Ward 4 in the city of Fort Smith, Arkansas, on **Tuesday, August 9, 2016** for the purpose of electing a City Director for Ward 4. In the event no candidate receives a majority of the votes cast in the primary, the two (2) candidates receiving the highest number of votes for the office of City Director Ward 4 will be voted upon in the municipal general election November 8, 2016.

The following four (4) candidates shall be listed on the municipal primary election ballot in the order as follows:

Zachary Muncrief  
George C. Catsavis  
Robyn Dawson

Early voting will take place from 8:00 a.m. to 5:00 p.m., Tuesday, August 2, 2016 through Friday, August 5, 2016, and Monday, August 8, 2016, in the Sebastian County Courthouse, 35 South 6<sup>th</sup> Street, Room G8.

Election day voting will occur from 7:30 a.m. to 7:30 p.m. at the below noted locations:
