The street department budget for 2017 included the purchase of a 30,000 lb. Excavator with an estimated cost of \$130,000. This memo summarizes the bids and the proposed purchase.

The department decided to go with a purchase in lieu of continuing renting an excavator for 4 months every year. This will allow greater flexibility in schedules and the equipment can be used in other programs as needed. We have been spending about \$15,000 per year renting an excavator.
