2 (TWO) EXCAVATORS


BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE CITY



The 2016 Budget earmarked the purchase of two excavators for the Sewer Line Maintenance Division of the Utilities Department which was approved on December 1, 2015 by Ordinance No. 88-15. This purchase is budgeted for as Water and Sewer Capital relative to the Consent Decree Bond Proceeds.

In December of 2005, the Board of Directors approved Ordinance 93-05, thereby authorizing the city to participate in the State Cooperative Purchasing program. This process has enabled us to take advantage of other negotiated contracts that the State of Arkansas currently participates in.

One of these contracts is the National Joint Powers Alliance (NJPA), a national municipal contracting agency offering national contract purchasing solutions by facilitating and awarding national competitively bid contracts. Because of their contract, local governments nationwide are permitted to purchase through their cooperative purchasing program.

The Utilities Department has budgeted \$180,000 for this purchase. Because of the NJPA contract, bids were solicited from local NJPA approved vendors and the bid received from Riggs Caterpillar in the amount of \$131,252.96 is the lowest and approved bid. As noted in the attached memorandum from Mr. Jimmie Johnson, this purchase is an addition to the existing equipment due to the Consent Decree mandates.

Please be advised that this purchase fulfils all of the purchasing obligations as mandated by both state and local purchasing requirements; I am therefore recommending that the enclosed resolution is approved.

Please let me know if should require any additional information.
