MINIMUM REQUIREMENTS FOR Plan Review Check List

NEW STRUCTURES OR ADDITIONS

	Cover Sheet	Make sure that the minimum requirements (per the minimum requirements for Building Permits outline) are provided on the cover sheet. Be sure we have a use listed for the structure (previous use and proposed use). Provide a life safety plan along with a code analysis.
[Survey	Make sure there is a survey with a stamp and signature from a surveyor licensed to practice in State of Arkansas.
[Site Plan	Make sure there is a site plan with a stamp from an Engineer or Architect licensed in the State of Arkansas. Make sure there is a parking plan with dimensions included.
		Trash/Mechanical screening details
	Landscape Plan	Make sure Landscape plan has a listing of plants and locations.
	Drainage Plan	Make sure there is a drainage plan submitted.
	Erosion Control	All drainage must conform to the 2011 City of Fort Smith Drainage Standards.
	Utility Site Plan	Make sure the site plan shows the utility connection points and the locations of all utilities proposed and existing.
	Foundation Plan	Make sure there is a foundation plan with a stamp of an Engineer licensed to practice in the State of Arkansas along with a seismic certification, if required. Seismic certification is required for any addition 4,000 sf and any new commercial building.
	Floor Plan	Make sure the floor plan is dimensioned along with room names or use, drawn to scale.
	Schedules	Make sure there are door, window and finish schedules.
	Sections	Make sure there are wall, floor and ceiling sections showing the construction methods. Details for all fire rated construction shall be included.
	Framing Plan	Make sure that there is a floor, ceiling and roof framing plans for an addition or new construction. Make sure that structural plans contain the stamp of an engineer licensed in the State of Arkansas along with seismic certification if required (see requirements of Foundation Plan). Details of the methods of construction shall be included.
	Elevations	Make sure there is an elevation of each side of the building. This shall show all materials with construction notes and height dimensions.
	Plumbing	Make sure there are complete plumbing drawings included. This shall include riser diagrams and schedules for both gas and water.

Mechanical	Make sure there are complete mechanical drawings included, including details and schedules.
Electrical	Make sure there are complete electrical drawings included. This shall include a riser diagram and schedules.

Be sure that the routing form states if the building has a fire sprinkler system, if so, what type of sprinkler system is proposed.

Be sure that the plans are stamped by an Architect/Engineer/ or Land Surveyor licensed in the State of Arkansas.

This list represents the minimum required drawings. If the plans are not complete, return to applicant until the complete plans are submitted. The Building Official is authorized to make exceptions.
