SUBJECT: Basin 10 and 14 Capacity Improvements Schedule 1-Final Pay to McKee Utility

Contractors, Inc.

SUMMARY

On July 19, 2022, the Board of Directors approved the bid of McKee Utility Contractors, Inc., in the amount of \$12,824,091.00 (R-109-22). The scope of this project included the installation of larger pipe, and changing the pipe alignment, to improve the flow capacity in the indicated section of the sanitary sewer collection system. On May 16, 2023, Change Order No. 1 was approved by the Board of Directors to replace the basketball court at Martin Luther King, Jr. Park, in the amount of \$158,706.11 (R-90-23), increasing the total project amount to \$12,982,797.11. Change Order No. 2 has been processed to reconcile the project costs. A project summary and presentation are attached for your review.

Work on this project has been completed. The Notice to Proceed was issued on November 14, 2022. The actual project final completion date was May 08, 2024.

A Resolution accepting the project as complete and authorizing final payment to McKee Utility Contractors, Inc., for \$174,582.74 is attached. The funding for this project is available from the 6505 ARPA fund.


