
RESOLUTION ACCEPTING BID FOR THE PURCHASE AND

At the November 6, 2018 meeting, the Board of Directors approved Ordinance 91-18 thereby amending the Police Department budget and approving \$1,400,000 for the purchase of various capital items. One of these requests was for a gated perimeter fence around the Police Department.

Bids were solicited for the purchase and installation of a perimeter fence, gates, and access control to be placed around the Police Department. The bid opening was held on Friday, December 7, 2018 at 2:00 PM.

A total of three bids were received, one of which (Ace Fence) was well after the time deadline. Although the bid from Robinson Fence Company was the lowest by \$2,670, it is our recommendation that we accept the bid from United Fence & Construction Company of North Little Rock instead. Attached is supporting documentation from the Police Department. Noted below are the reasons for this recommendation:

- United Fence met all criteria of the bid (see bid tabulation)
- Although not mandatory, United Fence conducted site visits whereas Robinson Fence did not.
- Robinson Fence bid was non responsive.

Funding for this project has been appropriated for per Ordinance 91-18 and is available from the Capital Outlay - Other account (47010101-531950).

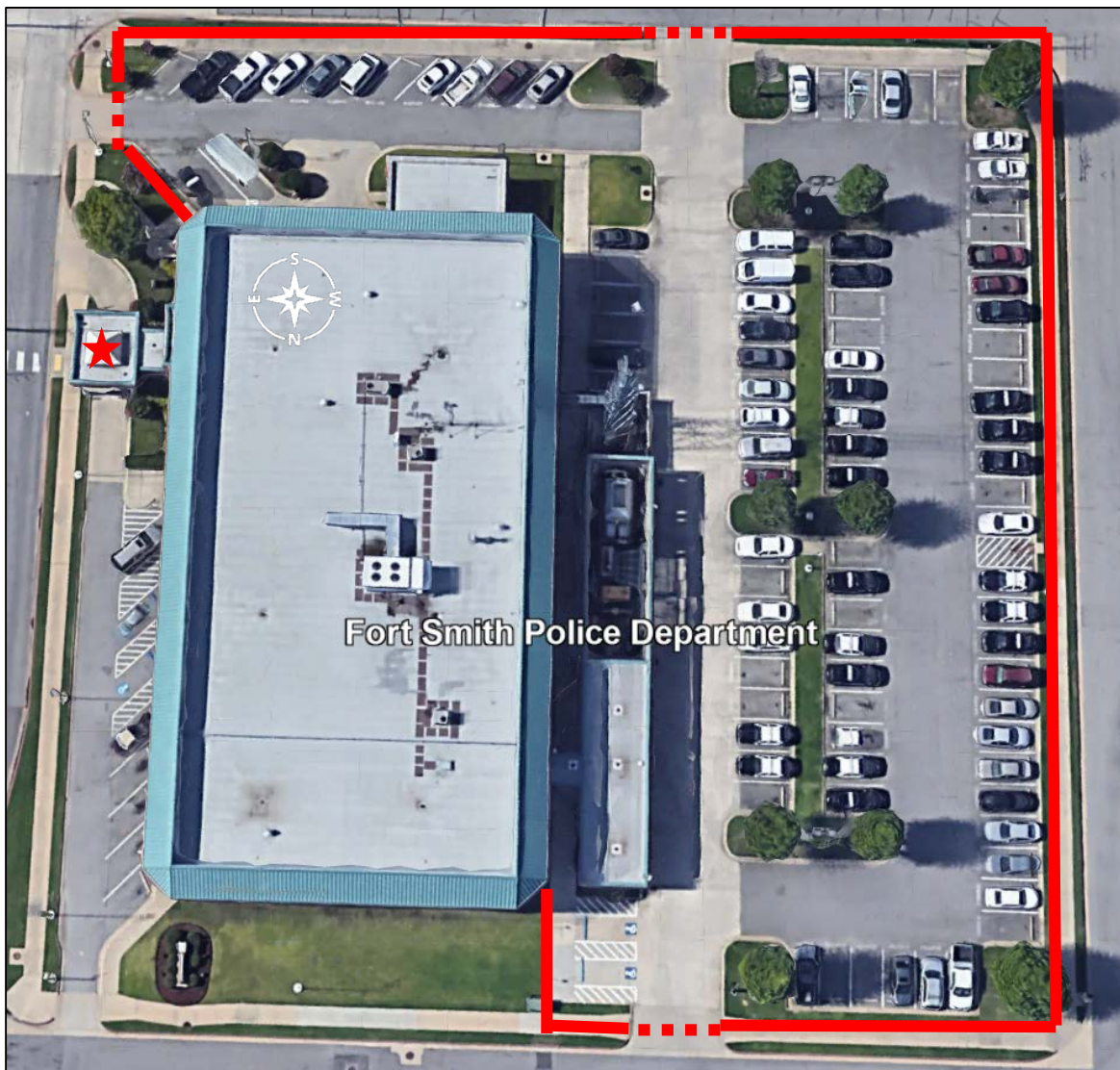
I recommend that the bid noted by enclosure on the attached bid tabulation be accepted.
