The bid, as indicated by enclosure for the purchase of a residential dial-a-truck for \$188,146.30, is accepted.



Per Ordinance 93-05, the City is authorized to participate in the State Cooperative Purchasing program. This process has enabled the City to take advantage of other negotiated contracts that the State of Arkansas currently participates in. One of these contracts is Sourcewell, a national municipal contracting agency offering national contract purchasing solutions by facilitating and awarding national competitively bid contracts. Because of their contract, local governments nationwide are permitted to purchase through their cooperative purchasing program.

This is to certify that River City Hydraulics of Sherwood, Arkansas is a member of the Sourcewell cooperative consortium network and is the regional distributor of residential solid waste trucks under Contract No.040621-P11.

The attached resolution is to authorize the purchase of a residential dial-a-truck for \$188,146.30. Although this item is not budgeted for, funds received from the insurance settlement of two burnt trucks (see attached memorandum from Mr. Terry Rankin) will be appropriated (per Ordinance 6 on the agenda) to the Capital Outlay-Heavy Equipment account (63022104-531200) of the Residential Collection Division of the Solid Waste Department.

Be advised that this resolution and purchase fulfills all of the purchasing obligations as mandated by both state and local purchasing requirements and I am therefore recommending that the enclosed resolution is approved.

Re: Residential Dial-A-Truck Purchase

On March 7, 2022, the Solid Waste Department experienced a fire that burned two residential collection trucks. One was an automated side loader that has already been replaced by last year's purchase/scheduled replacement. The other was a dial-a-truck. The Solid Waste Department is requesting to purchase a new dial-a-truck with the money received from the insurance claim.

The Solid Waste Department has two dial-a-trucks. They are both essential vehicles in the everyday operation of the residential division. They are used to pick up large items that are set out by the citizens of Fort Smith, picking up storm debris, Spring and Fall clean-ups, and by having two, there is always a backup when one is being serviced. Due to the importance of the dial-a-truck operations, we are requesting a diesel powered truck, which will be delivered in 90 days, rather than a CNG powered truck, which will take more than a year for delivery. The dial-a-truck will be new Freightliner chassis with a Petersen body and knuckle boom. We will use the Sourcewell purchasing cooperative and will arrive within 90 days. The cost for this purchase is \$188,146.30. The funds are available from the combined insurance proceeds of \$222,266 from both of the lost trucks.
