
The bid, as indicated by enclosure for the purchase of a haul truck from Stribling Equipment for \$571,046.16, is accepted.

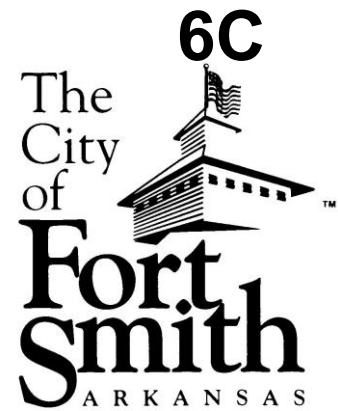

Per Ordinance 93-05, the City is authorized to participate in the State Cooperative Purchasing program. This process has enabled the City to take advantage of other negotiated contracts that the State of Arkansas currently participates in. One of these contracts is Sourcewell, a national municipal contracting agency offering national contract purchasing solutions by facilitating and awarding national competitively bid contracts. Because of their contract, local governments nationwide are permitted to purchase through their cooperative purchasing program.

This is to certify that Stribling Equipment of Fort Smith is a member of the Sourcewell cooperative consortium network and is the local distributor of John Deere articulated dump trucks under Contract No. 032119-JDC .

The attached resolution is to authorize the purchase of a John Deere articulated dump truck for \$571,046.16. Funding for this bulldozer has been appropriated for in the 2022 Budget under the Sanitary Landfill Equipment Replacement Fund (11186065-531200).

Be advised that this resolution and purchase fulfills all of the purchasing obligations as mandated by both state and local purchasing requirements and I am therefore recommending that the enclosed resolution is approved.

Re: Heavy Equipment Purchases

In accordance with the 2022 Solid Waste Services Capital Improvement Plan, the Department of Solid Waste will be purchasing the following heavy equipment:

- Landfill D8 Dozer
- Landfill Haul Truck

The landfill D8 dozer will be a 2022 Cat D8T. This purchase will be made through Sourcewell. This will be an additional dozer to the existing landfill equipment. The current D8 will move to be a reserve dozer that will primarily be utilized in routine landfill cell maintenance and when the 2022 Cat dozer is being serviced or repaired. The Department is currently renting a John Deere 700 to temporarily serve in this capacity and it will eliminate the need to continue this agreement at a rate of \$42,492 every 6 months.

The landfill haul truck will be a 2022 John Deere 410E. This purchase will be made through Sourcewell. It will replace the 2016 Terex TA 400, asset 4038. The unit being replaced has 10,106 hours. Over the past 4 years we have spent \$281,645. This unit has had several major issues, such as transmission replacement, brake pistons leaking, and the fender, which houses the battery box and hydraulic tank, continues to break after the dealer has repaired it, modified it and repaired it again.
