SUMMARY

At the final budget review session on December 14, 2023 two Directors moved to add to the agenda a prioritized list of "New Needs" budget requests as an amendment to the base 2024 budget. The amendment to the base 2024 budget was tabled to the January 18, 2024 special meeting at the December 19, 2023 regular meeting. The January 18, 2024 meeting was cancelled due to inclement weather and was difficult to reschedule. It has been scheduled for a Special Study Session on March 18, 2024.
